On Friday, March 24th, lifetime member Ruth Licata was recognized for her 50 years of community and civic participation with a star on the Palm Springs Walk of Stars. Friends, League members, and dignitaries spoke of Ruth's strong sense of equality and justice, providing snippets of her work to highlight her many contributions. The ceremony and reception were well-timed, coming just at the tailend of Sunshine Week—a week when groups across America are focusing on open and participatory government.

LWVC President Jackie Jacobberger sent a letter of congratulations and a vase of yellow roses was presented on behalf of our local League. Ruth's shining star is #268 on the Palm Springs walk, and is located at 222 S. Palm Canyon Drive, in front of La Casuelas Terraza Restaurant.

Ruth related how at age 11, she attended a rally for votes for women with her mother. Now, at 96 years old, Ruth recalled the event and credited that day as the beginning of her own activism.

We don't know if Ruth ever met Carrie Chapman Catt, but she well might have. Mrs. Catt is generally credited as the founder of the League. In April 1919, she wrote, "The politicians used to ask why we wanted to vote. They seemed to think we want to do something particular with it, something we were not telling about. They did not understand that women wanted to help improve the general welfare of the people". The 'general welfare of the people' has always been Ruth's driving interest, and this she has done.

NEWS FROM NATIONAL

"Are We Safer in the Dark?" was a panel discussion hosted by LWVUS and several other national organizations during Sunshine Week (March 12-18). The effort was to shed light on the growing lack of government transparency. Many Leagues across the country also held Sunshine Week events.

Looking for Sunshine: Protecting Your Right to Know, is a resource guide to assist organizations interested in openness in government. It can be downloaded from the national website, www.lwv.org. The guide provides an overview of the most significant federal and state laws—those that protect and those that restrict public access to government information—and suggests ways to become more active in this area. Copies of this resource guide (Pub. #2077) are \$4.50 and are available through pubsales@lwv.org.

"Courts are Different" - An Article by Professor Luke Bierman, Director of the Institute for Emerging Issues at North Carolina State University, supports the League's <u>Safeguarding the U.S. Democracy</u> program. This project is the League's nationwide educational effort to promote an independent judiciary. Bierman's article explains why separate institutions, with unique functions and responsibilities, lie at the core of American Governance.

NATIONAL LEGISLATION TO WATCH

FEC Internet Regulation

The League applauds the internet regulation adopted by the Federal Election Commission (FEC) on March 27, which strikes a balance between protecting free speech and campaign finance laws. However, League opposes H.R. 1606 (Hensarling) which would gut campaign finance laws and the soft money ban.

The League **opposes** oil drilling in the Arctic National Wildlife Refuge (ANWR).

The League expressed concerns to the U.S. Election Assistance Commission (EAC) about implementation of the National Voter Registration Act in the states.

A coalition of groups sent a letter urging support for lobby reform legislation that effectively addresses the issues of enforcement, trave, disclosure, the revolving door and gifts. A statement entitled "Six Benchmarks for Lobbying Reform" is available online at

American Democracy at Risk: Agenda for Renewal and Repair

a speech by LWVUS President Kay J. Maxwell Santa Fe, New Mexico January 31, 2006

"Years of band-aid solutions and neglect have allowed many of our government systems to grow weak. Our Democracy Agenda offers viable solutions to help overcome those weaknesses. and communities and citizens nationwide, on how to improve things. This effort is about protecting our electoral processes through election reform efforts and reauthorization of the Voting Rights Act; advancing our representative government through nonpartisan redistricting; preserving constitutional rights by safeguarding civil liberties; and protecting against government corruption through campaign finance and lobbying reform."

"Democracy is at risk when long lines and faulty voting processes keep Americans from voting and having their votes counted. Democracy is at risk when partisan gerrymandering ensures that elections are over before the people vote. Democracy is at risk when government actions threaten basic civil liberties. And, democracy is at risk when special interest money plays a dominant role. We believe we must renew and repair our democracy so that it truly works for all citizens."


